**ESTABLISHMENT OF A PRIVATE NATURE RESERVE**

It gives me great pleasure to inform you that your application on behalf of the Banghoek Body Corporate for the establishment of a private nature reserve on the properties being Portion 1 of the Farm Banghoek No. 87 and Portion 2 (Matjesfontein) of the Farm 't Voetpad No.82, Piketberg, has been approved. A notice to this effect will shortly be published in the Provincial Gazette.
